## WHO ARE WE?

We are the only Kent-based funeral company specialising in and only providing direct cremations.

We are primarily based online. Our friendly team will help make arrangements over the phone or if you wish we can also arrange in person meetings at your home.

Your loved one will be kept at our care facility in Broadstairs until the time of their cremation at the local crematorium in Margate\*.

After the cremation inline with your wishes we will bring your loved ones ashes to you by hand for peace of mind, knowing they back to you safely.

\*Subject to availability, in some instances with your consent where there is limited availability at Thanet Crematorium we may arrange for a cremation at. Herne Bay, Barham or Faversham Crematoriums at no extra cost.



## WHAT TO DO

When a death occurs at a hospice or hospital:

(Including unexpected passings)



We will need to wait for the coroner, hospital or hospice doctor to issue some paperwork.

With the exception of most hospices this is a few days (but may be sometimes weeks) after the passing but you can call us immediately so we are ready to collect your loved one when they are cleared by the relevant authority

When a death occurs at home or a nursing home:



Call 01843 663 206 and our team will be with you as soon as possible to transfer the person who has passed away into our care.

You will need to wait until the district nurse or relevant medical professional has verified the passing



Once your loved one is cleared by the relevant authority all you need to do is register the death and we will handle the rest. The GP/ Hospital or Coroner will advise when you can do this



The Registrar will send us the "Green Form" which allows the cremation to go ahead, once we have this we will arrange to book the cremation.

## **HOW IT WORKS**

#### Appointment

When you have registered we will arrange to see you, speak over the phone or via email to confirm a date and sign the forms necessary for the cremation to take place

#### Payment

Payment must be made prior to the cremation taking place, except where the account is passed on to a bank, building society, the Department of Work and Pensions or a solicitor as we will liaise with them directly.

#### Cremation

We will take your loved one in a coffin transported by hearse directly to the crematorium to be cremated on the chosen day. They will be taken into the chapel to your chosen piece of music.

#### Returning the Ashes

Depending on what you choose we will usually arrange to hand deliver the ashes back to you at a pre-arranged time and day to suit you






